The Committee recognizes CDC's leadership in implementing this program and awarding valuable and impactful cooperative agreements to stakeholders to improve professional and public awareness about chronic diseases not addressed by a specific CDC program. As program resources increase, CDC is encouraged to ensure that smaller partners and rare disease organizations have an opportunity to compete for cooperative agreements, and that CDC is able to simultaneously support condition-specific projects along with over-arching chronic disease projects addressing distinct public health activities.
