

## **Additional Information for State Medicaid Fee-For- Service Programs Covering Lung Cancer Screening**

**Notes:** In 2013, the US Preventive Services Task Force (USPSTF) recommended lung cancer screening for individuals ages 55 to 80 years who have a smoking history of 30 pack years and currently smoke or have quit smoking within the last 15 years. In 2021, USPSTF expanded that recommendation to include individuals ages 50 to 80 years who have a smoking history of 20 pack years and currently smoke or have quit smoking within the last 15 years. If a state demonstrated that it had updated to the 2021 guidelines, that is noted in the table.

As of February 2022, Medicare covers screening for individuals ages 50 to 77 years who have a smoking history of 20 pack years and currently smoke or have quit smoking within the last 15 years.

Finally, "other" includes programs that have criteria that is similar but slightly different from USPSTF or Medicare, as well as programs that have no formal eligibility criteria for screening, while "not available" indicates that we were unable to confirm which eligibility criteria the state was using.
